



- a footprint in the sand

When Chuck and Susan were making their estate plans, they said that including the Conservancy wasn't a difficult decision. "And not just me and Susan, but our kids and grandchildren." Knowing that they've passed their love for this corner of the world down their family tree had given them further comfort in becoming Heritage Society members. - if you love something, you should protect it

When Heritage Society member Larry Noling passed, his children remembered the precious time the family had spent in Leelanau. "Our family started coming up to Leelanau from Indianapolis in the mid-'30s. After the war, they built a small house on a hill, and around 1949 they built the main house down by the lake. It's been in the family ever since," said son David Noling.

Daughter Susan Pandorf now lives in Leelanau full-time. "The fondness I have for this area is immeasurable," she said. "We are now bringing the fifth generation to Leelanau, and it's a great joy to me when they're here. My eldest grandson will be 15



this summer, and the first summer, he came up here and spent five days. The next year he spent a week; the year after was two weeks, and at this point, he's here almost all summer. We've always been aware of the Conservancy's work. David started gifting Dad contributions to the Conservancy on Father's Day and his birthday. Dad even has a tile with his name on it at the Village Green. He had 15 grandchildren and eight great-grandchildren between me, David, and our sister Jamie. He never wanted expensive cars or fancy jewelry; what he loved most was his family and sharing Leelanau with them. Something that stood out to me in his instructions was, 'When in doubt, always trust the people of Leelanau County. I have, and they've never failed me.' He strongly believed that if you love something, you should protect it. His membership in the Heritage Society supported those beliefs, and we support them too."

CAMMIE BUEHLER

- a 5th generation Leelanau summer kid

Cammie calls herself "a 5th generation Leelanau summer kid," and her roots in this peninsula run deep. Her great-great grandfather was a mining engineer who came to Omena in 1903. Over her life, Cammie spent time in Northport and Omena. "Leelanau is in my cellular matrix," she says.

Her love for Leelanau and "cellular matrix" factor sums up what inspired Cammie to join the Leelanau Conservancy's Board of Directors in 2018, and most recently, why she joined the Richard O. Ristine Heritage Society.

A cancer scare at age 40 led her to create a will. The tumor of concern turned out to be benign, but the ordeal propelled her to get her affairs in order. "I feel lucky and grateful, and that's what inspired me to write a will." She consulted with an attorney and created a trust to avoid probate. "I've



provisioned a flat amount to go to the Conservancy, and will reassess things as I age," adds Cammie.


"Not a lot of my peers have a will," she says. "But I figure that all the people before me have made sure that the Leelanau I love was there for me and now it's on me to help steward this peninsula for all who come after me."

Dad was impressed by the impact that the Leelanau Conservancy was making in protecting the natural resources of the county. He found particularly appealing its efforts to protect family farms and water quality, and the Conservancy quickly became the primary focus of Dad's volunteer efforts. 

The Leelanau Conservancy is a 501(c)3 nonprofit organization, led by a dedicated Board of Directors. Our financial due diligence includes annual financial audits and regular oversight by the Finance Committee and the full Board. Established in 1988, the Conservancy has been in operation for more than 35 years, faithfully serving the community and protecting the land, water and scenic quality of Leelanau County.

Our primary source of revenue is from cash donations from private supporters, and the majority of funds spent go toward the land-protection and stewardship programs. We are grateful for the trust and confidence of our community that allows land protection, land stewardship, and operations to continue. The work we are able to accomplish with your support benefits everyone. The Leelanau Conservancy also maintains endowment funds; a general endowment and a stewardship endowment to protect land into perpetuity. Planned gifts, unless otherwise designated, are invested in the endowment funds to ensure future operations and care for our lands.

NEXT STEPS

- Planned giving is an expression of your values. Consider what has been most important for you, what you would like your legacy to be, and how you may be able to support that through a charitable planned gift.
- The process is simple, but we always recommend seeking independent professional advice. Contact your financial advisor or lawyer to discuss options that are best for your situation. The most popular planned gifts are charitable bequests in wills. An advisor can assist you in creating or amending your will, and help you understand tax advantages to various other gift types such as specialized trusts. You may also consider naming the conservancy as a designated beneficiary of an IRA or other accounts.
- Provide your financial planner with the information on the next page, including our contact information and details.
- Discuss your plans with family members. Sharing this information can be beneficial in helping your family to understand your values and know what to expect. Many families tell us how proud they are of their parents or grandparents for remembering Leelanau in their legacies.
- Let us know about your intentions. Please share with us that you have designated a planned gift. This helps us to document and honor your intentions, and to say thank you! You can provide whatever level of details you are comfortable sharing, and your gift can be anonymous if you prefer.
